WHEREAS the government of Arunachal Pradesh by Notification No.LR-103/84/1691 dated 27th October,2010 and No.LM-33/2010 dated 12.3.2011,under section 6(1) of Land Acquisition Act, 1894,has acquired land required for a company namely Tato Hydro Power Pvt.Ltd (A SPV of Reliance Power Ltd) for execution of 700 MV Tato-II Hydro Electric Project for public purpose and give notice of its intension to acquire the land specified in the Schedule hereto given below;

And Whereas the State of Arunachal Pradesh and the Tato-II Hydro Power Private Limited has signed MOU for construction of a 700 MW Hydro Project at Tato and the Administrator for Rehabilitation and Resettlement has undertaken a baseline Survey and Census for identification of persons and families likely to be affected as required under paragraph 7.1.6 of Rehabilitation and Resettlement Policy,

And whereas the baseline survey contained the following village-wise information of the affected families;

(i)Members of the family, who are permanently residing, engaged in any trade, business, occupation or vocation in the affected area.

(ii) Families who are likely to lose or have lost, their house, agriculture land, employment or are alienated wholly or substantially from the main source of their trade, business, occupation or vocation.

(iii) Agriculture labours and non agricultural labours.

(iv) vulnerable persons such as the disabled, destitute, orphans, widow, unmarried girls, abandoned women or persons above fifty years of age, who are not provided or cannot immediately be provided with alternative livelihood, and who are not otherwise covered as part of a family,

(v) families that are landless (not having homestead land, agricultural land, or either homestead or agricultural land) and below poverty line, but residing continuously for a period of not less than three (3) years in the affected area preceding the date of declaration of the affected area and,

(vi) Scheduled Tribes families who are or were having possession of forest land in the affected area prior to the 13th day of December, 2005,

And Whereas, the above said baseline survey has been completed under paragraph 7.1.6 of Rehabilitation and Resettlement Policy, the undersigned being the Administrator is hereby publish the draft of the details of the findings of the survey conducted (enclosed at Annexure-"A") for wide publicity and invite objections and suggestions from all persons likely to be affected thereby within 30 (thirty) days from the date of publication of this Notification. Objections and suggestions, if any should be submitted to the undersigned within the prescribed time for consideration of the suggestions and objections. Suggestions and objections received after the prescribed time limit of 30(thirty) days will not be considered.
